#### **CAPABILITY STATEMENT**

#### **ORGANISATIONAL OBJECTIVES**

The underpinning philosophy behind the formation of Bundaberg Sugar Services Limited was the acknowledgement by Bundaberg Sugar and CANEGROWERS of the joint responsibility for ensuring the Bundaberg sugar industry's sustainability and the need to work together and to work smarter.

The objectives of Bundaberg Sugar Services Limited are:

- to enhance the productivity of the sugar industry by increasing the quantity and improving the quality of cane produced by crops grown in the Bundaberg district;
- to achieve regional sustainability in the Bundaberg area through full utilisation of sugar industry capital;
- to provide suitable advice and help to members about:
  - the prevention, control and eradication of pest infestation and disease of cane or any other matter or thing that adversely affects the quantity or quality of crops of cane; and/or
  - the production and harvesting of cane;
- to help, and cooperate with, other bodies involved in preventing, controlling and eradicating pests in cane;
- to help, and cooperate with, other bodies involved in researching the production, harvesting, transport and processing of cane;
- to provide advice and information to members for the preservation and enhancement of the capacity of land to sustain crops of cane;
- to help minimise any damage to the environment that may be caused by activities of the sugar industry within our area.

#### **ORGANISATIONAL SKILLS**

Bundaberg Sugar Services Limited is a Public Company Limited by Guarantee, and is a not-for-profit Organisation whose funding is provided by a levy on grower members. Bundaberg Sugar Services Limited is controlled by a board of directors, two (2) of which are appointed by growers and two (2) appointed by the mill.

Bundaberg Sugar Services Limited has previously managed funding projects for Department of Agriculture, Fisheries and Forestry, Department of Employment & Training, Qld Department of Primary Industries, The Department of Natural Resources and Mines, Department of State Development, Burnett Mary Regional Group and Sugar Research and Development Corporation.

Bundaberg Sugar Services Limited has experience in managing community based projects and has the necessary personnel, systems and procedures to provide the essential level of corporate governance, management, supervision and administration to direct projects.

Bundaberg Sugar Services Limited also provides direct and extension services such as:

- Approved seed cane for planting;
- Excellent, readily accessible advice;
- Help to identify and control cane pests and diseases;

#### ANNUAL REPORT 2022/23

We present the report for the financial year 2022/23.

During the past twelve months Michael Turner has been the only full-time employee. As flagged last year the one-eye sett (OES) propagation and pest and disease core programs undertaken by Michael Turner were prioritised as they are critical to our industry.

Michael has focussed his attention on needs based and member focussed programs which consist of the approved plants scheme, plant source inspections, approved seed distribution, pest and disease management and general extension.

Casuals have been employed to assist when required and more recently an understudy to Michael has been engaged.

On behalf of our members, we would like to acknowledge the service, assistance, and dedication that Michael Turner provides to Bundaberg Sugar Services Limited.

We have been able to identify and secure suitable nursery facilities on a long-term lease basis that will enable continued expansion of the one-eye sett propagation that has become the cornerstone of our industry. The expansion of this system will enable BSSL to produce even more high-quality seedlings on demand.

The BSSL Board reaffirmed our policy with respect to how the BSSL/SRA relationship strategy operates.

This was communicated to SRA to assist them target areas of mutual interest in areas and programs and services that we cannot effectively deliver ourselves.

- We see potential for RSD and potentially YCS identification to be incorporated into the NIR analysis as cane goes through the mill. This may enable the cessation of costly and resource consuming surveys that do not cover all potential planting sources and have inherent inaccuracies.
- The breeding program, which we see as SRA core business, although we wish to see more concentration on areas such as breeding drought resistance. We would also like to see a review of the old varieties to ascertain attributes that might be of use in combatting YCS and soldier fly.

We would like to thank a wide range of sugar industry organisations, particularly Bundaberg Sugar Ltd and Bundaberg CANEGROWERS Ltd for their assistance in helping Bundaberg Sugar Services Limited to meet our objectives.

We would also like to acknowledge and thank Dr Jason Eglington and Mr Roy Parfitt from SRA's variety development team for enabling and facilitating the use of the Bundaberg SRA facility to grow out extra orders of OES that we would otherwise not have been able to do.

On behalf of the Board, we would also like to formally acknowledge our members who are the reason why Bundaberg Sugar Services Limited exists in the first place.

#### CORE PROGRAMS

#### APPROVED SEED PRODUCTION AND DISTRIBUTION

The approved Seed Production and Distribution program ensures that all Bundaberg Sugar Services Limited plots are sampled for RSD, planted with the selected varieties and routinely inspected. As a service to members inspection of plant sources on individual farms is carried out upon request. The approved seed production is our core business and it is critical that we maintain and where possible, modernise how this service is delivered.

#### **Approved Plants Scheme**

The usual preparations for plants distribution, including organising mailing of grower order forms, confirmation of orders, plot inspections, machinery hire, labour requirements and RSD testing of the plots were conducted. DNA samples were also taken on the varieties planted in the mother plot.

Three (3) general disease inspections were conducted at regular intervals during the year. No disease or other issues were detected during these inspections. The mother plot was chipped on a regular basis for weeds.

#### **Plant Source Inspections**

Twenty-nine (29) growers including Bundaberg Sugar requested plant source inspections and RSD tests on sources. No sources were identified with smut. Five (5) blocks returned a positive result of RSD. All growers were sent notification letters outlining the results.

The spring 2022 plot was planted on the  $26^{th}$  and  $27^{th}$ September. All the planting sources for mother plot planting are derived from tissue culture to maintain integrity of the variety.

Since the inception of one-eye setts (2019) there has been a marked increase in the number of seedlings purchased by growers each year to the point where we have outgrown the current facility and are in the process of moving to a new facility.

Some growers are ordering enough seedlings to plant up to one (1) hectare of approved seed cane.

#### Spring 2022

The distribution of spring 2022 seedlings commenced on 16<sup>th</sup> August. Seventeen (17) growers collected 32,320 seedlings. There were no orders from Bundaberg Sugar farms.

#### Autumn 2022

The autumn 2022 distribution of seedlings commenced on  $17^{\text{th}}$  March. Twelve (12) growers including four (4) Bundaberg Sugar company farms collected 40,448 seedlings.

#### Seedling water wheel planter

Bundaberg Sugar Services have a dedicated seedling planter available for growers to borrow to plant their seedlings. The planter is delivered to their farm and collected once they are finished using it by Sugar Services staff. Fifteen (15) growers have taken up the option of using the planter rather than planting seedlings by hand.

There have been no major issues with the planter. Two D-shackles were replaced on the seat rails.

#### PEST AND DISEASE MANAGEMENT

Pest and disease management remains a vital function of Bundaberg Sugar Services Limited who carry out farm inspection and interpretation of specific pest or disease incidence at the request of grower members.

One of our objectives is to provide suitable advice and help to the members about the prevention, control and eradication of pest infection and disease of cane or any other matter or thing that adversely affects the quantity and quality of crops of cane and/or the production and harvesting of cane.

#### Yellow Canopy Syndrome (YCS)

The 2022/23 season observations identified there was some YCS present throughout the Bundaberg district, but not to the same extent as previous seasons. Some of these blocks identified were in previous seasons observations.

#### Ratoon Stunting Disease

Ratoon Stunting Disease (RSD) remains a major disease facing the Bundaberg district.

Bundaberg Sugar Services Limited conducts annual surveys across the district to identify the extent of this disease and promotes the regular use of recommended hygiene measures to manage this disease.

RSD testing of the mother plot at Clayton Road was conducted with forty-six (46) samples collected using the new method of bulking stalks from a block or individual variety and sending the sample to SRA Brisbane for analysis. Samples are collected every ten (10) metres in the mother plot. All samples returned a negative result.

#### **Machinery Inspections**

There were no requests for machinery inspections in the last twelve (12) months. Any inspections requested are directed to the relevant authorised person at the Biosecurity office (DAF) Bundaberg.

#### Planting, Pest & Disease Data Collection

Due to other work commitments a small number of grower members were surveyed including Bundaberg Sugar farms across the Bundaberg mill area.

Information collected includes where approved seed cane was planted, row spacings, GPS planted or block just marked out by GPS, break crop rotation (soybean, peanut, smallcrops), pest or disease problems (e.g., cane grubs area affected, tonnes loss) irrigation type, fertiliser/insecticide use.

This information gives us an idea of what is going on around the district and where we need to tackle a pest, disease, or nutrient situation.

#### **Grower requested nutrient requests**

During the past twelve (12) months, several growers have taken advantage of the service provided by BSSL. Thirty-four (34) blocks were sampled to determine the current nutrient status and requirements for plant and ratoon crops.

Growers are provided with a nutrient management plan when receiving their results.



During the 2022/23 year there were 34 soil tests representing 16 growers.
