Chair's Update

The beginning of November saw the weather change with some intense storms and rain, the harvest had been running fairly smoothly up to this point with only minimal rain in early September, then a dry October. With the rain events to date the CCS has topped the annual curve and is on a downhill slide with the weekly CCS now 13.73. The season average CCS is still sitting at 14.03 which is not a bad outcome for the year so far.

Mill reliability has been quite reasonable except for the failure of No. 5 mill whilst No. 2 mill was also offline. The decision to keep going with No. 2 and No. 5 mill bypassed was greatly appreciated albeit at a reduced throughput. I can't say the same thing about the transport system though, with prolonged bin deliveries resulting in bins not being filled, and cut to crush times blowing out, somewhat caused by difficulty in finding truck drivers, which I guess is a sign of the times that we live in.

With the rain and the temperature ramping up we are seeing next years crop starting to power away and hopefully we will be able to get the last of the crop off in not too long. The sugar price has taken a serious fall in the past couple of months with the price dipping below the cost of production for most growers. In saying that, as I write this there is a small rally in the price.

I urge growers to follow the pricing and speak with Glenn Harris about available pricing options to help soften the blow of the reduced world sugar price. It is disappointing that we are yet again seeing little to no Advance payments coming in due to the rapidly reducing price and it is hoped that in future seasons, QSL's FlexPay product

can be used to manage your cashflow to suit your needs.

With the longer season and low sugar prices the decision has been made to increase Base CCS to 13.80. You should see this adjustment in late November.

Soybeans have been a backstop in the past when the sugar price has been low and once again could make an excellent option to help with cashflow, not to mention how good they are for the soil. Matt is available to assist with a wealth of knowledge around the selection of varieties and the growing husbandry of soybeans. There is an article on page 6 providing some basic information.

The Irrigation Pricing Rebate Scheme is now open for applications to receive a 15% rebate to eligible businesses on bills issued by Sunwater, including Burnett Water. Tanya and Matt are available to assist with applications and further information can be found on page 3.

Cane planting wrapped up with an extremely good uptake of the Sugar Services' one-eye sett program. This is a great tool to help keep up to date with your clean seed program and new varieties. We farewelled David in October and are now seeking a full-time replacement. If you know someone who may be interested in the position, the vacancy advert is included on the last page and I ask you to encourage them to contact Tanya for further information.

While we are looking for a new person Matt Leighton will be helping with soil samples, and other BSSL roles to ensure growers are not impacted greatly.

Southern CANEGROWERS and Productivity Board representatives recently met to discuss the SRA Plant Breeding program and presented a proposal to Garry Rosewarne at SRA on the future of the Southern program and Regional Variety Selection Committee.

Lastly, we extend a huge congratulations to Shanon who recently received the East Coast Apprenticeships Trainee of the Year award. Many of you will recognise Shanon as the friendly, professional face at reception who greets you whilst also ensuring our office runs seamlessly.

Let's hope the weather holds out and we can get this harvest

season done and dusted in the very near future.

Notes

Under QSL's Advances program, supplying growers and millers are paid a proportional amount of their current estimated final sugar pricing result. The program is indicative only and may change during the course of the season, and so should not be taken as a commitment by QSL with regard to either the Advance rate or date of increase. The QSL Board reviews the program periodically to determine whether scheduled increases should be approved or amended, weighing factors such as movements in the marketing and shipping plans, sugar price and currency movements and the timing of cash flows. Suppliers' positions in relation to any pricing elections may also impact the timing and size of Advance payments. Based on indicative pool values, with a estimated combined QSL Harvest and US Quota pool value of \$482/t IPS as of 31 October 2025.


Note: The 'Applicable From' payment dates listed below may differ from your own payment dates due to your local milling arrangements and bank processing times.

This figure is an estimate only for the default QSL pricing position of 98% Harvest Pool + 2% US Quota Pool based on pool values as at the date specified. Please note that the pool values used to calculate the default payment will change as the season progresses. The default payment figure incorporates a weighted average Shared Pool allocation, with the Shared Pool allocation applied to grower payments varying in each region due to regional costs (regional Shared Pool details are available at www.qsl.com.au). The estimated payment figure quoted also does not include any applicable Loyalty Bonus, GST, allowances, deductions or any other adjustments incurred by the grower or passed on by their miller.

Accelerated Advances

Accelerated Advances Program participants receive 90% of their eligible products' indicative value by December each year. Under this scheme, Advance rates paid for tonnages in these products remain at 90% from each season, reverting to the QSL Standard Advance Rate from the subsequent May payment.

Irrigation Pricing Rebate Scheme

The Queensland Government has allocated \$25.3 million to the Irrigation Pricing Rebate Scheme to provide rebates of 15% to eligible businesses on water bills issued by Sunwater (including Burnett Water) in relation to the 2025–26 and 2026–27 financial years.

The 15% rebate will support owneroperated businesses that use water for irrigation and earn primary production income.

Am I eligible?

To be eligible for a 15% rebate on your quarterly water bills under the Scheme, your business must:

- have at least one owner who provides labour for the business
- not be wholly or partly operated or owned by one of these excluded entities:
 - o a public company
 - o a foreign company
 - o an entity operating a managed investment scheme; or
 - a superannuation entity other than
 a self-managed superannuation fund

- have at least one owner who declares primary production income for tax purposes
- grow crops requiring irrigation from time to time; and
- have paid a bill issued by Seqwater or Sunwater (including Burnett Water) related to your water allocations and usage for the 2025-26 and 2026-27 financial years.

For more information on the eligibility criteria for the Scheme, please see the Scheme guidelines.

Submitting an application

Applications can be completed online through the QRIDA application portal, or via the paper application form.

Your initial application with QRIDA must include:

- information on your owner-operated business
- evidence of primary production income
- evidence of irrigation activities
- your Sunwater or Burnett Water bill
 (s)
- evidence of your payment of bill(s)

sunwater

 where the bill is not issued to your business, information about your relationship with the entity which owns the water allocation consent for the name and customer reference number on the bill to be shared with your water supplier (Sunwater)

You may choose to submit a statutory declaration in place of evidence for irrigation activities and primary production income. Tanya Howard is a Commissioner for Declarations and is available to sign statutory declarations.

Once you have been approved for assistance under the Scheme, subsequent applications will only require invoices and proof of payment.

Applications close 31 December 2027, or when available funds are exhausted.

Workplace Health and Safety reminders

There have been a recent run of incidents and accidents on farms which have resulted in Work Place Health and Safety being involved. While this is never a pleasant experience, there are several things that growers can do to help themselves in case there is an issue.

- 1. Call 000 if required and provide support or medical assistance until help arrives
- 2. Secure the site and do not disturb the area surrounding the incident
- 3. Call WHS QLD on 1300 362 128. You must notify them of "notifiable incidents" which include a death, a serious injury or illness, or a dangerous incident.
- 4. Report the injury to WorkCover Queensland. This is a separate process from notifying WHSQ.

Once the incident site has settled the grower will need to conduct a review of the incident to ensure all policies and procedures were followed. From this review the policies and procedures may need to be updated or actions taken to ensure the incident doesn't

occur again.

When WHS officers visit the site they will look to see what policies and procedures are in place as well as conducting an inspection of any machinery involved and at the workplace. From this there may be a list of enforceable actions that are required to be completed and once notified to WHS.

Some common items that are regularly part of the enforceable action are:

- 1. Repairing/replacing any seat that has a tear in the cover
- 2. Ensuring keys are removed from vehicles at the end of the day. To ensure workers who are not authorised to use one type of vehicles such as a forklift or a light truck because they don't have the appropriate licence, consider placing keys in a lockbox with a pin code.
- 3. Safety data sheets for the agricultural chemicals as well as degreasers/lubricants, especially aerosol products that are used in

and around machinery and the workshop.

Other areas that can be identified include bunding for on farm fuel tanks, bunding and locked chemical storage area, machinery maintenance records, guarding for PTO drives on tractors and PTO shafts on machinery, slings and lifting gear checked and tagged every 12 months, portable RCD units in use for machinery run of a generator.

A form that can be useful if there is an incident is an emergency contact list for employees or regular helpers. This lists the name of the employee, their next of kin or preferred emergency contact and contact number and a blank sheet has been included for your convenience.

What is the best price and what product to use

As the forecast sugar price for 2025 crop continues to move further away from the \$700 per tonne IPS received in 2024, growers need to be aware of the best way to reduce input prices as well as maximising productivity.

To reduce input prices, The best way is to get good advice and focus on the price per hectare and not the price per drum or per tonne of fertiliser. In maximising productivity, the biggest restriction in Bundaberg is water and generally the more water used at the correct time equals a bigger crop.

When it comes to chemicals, it is not how much per drum that is the focus but how much per hectare when applied at the label rate.

As a replacement for Lorsban to control wireworm at planting, Talstar can be used and it is significantly cheaper per hectare despite the drum being more expensive.

Another example is comparing some common fertiliser blends. Two of the more common fertiliser blends for rations are CK 140(S) and High KS Rationer. When applied at 150 kg nitrogen per hectare there are some savings to be made.

There is a slight difference between CK 140(S) and High KS Ratooner as these are not like for like products especially with reef regulations, as when High KS Ratooner is recommended, CK 140(S) cannot be used as it has phosphorus whereas the High KS Ratooner does not.

For CK 140(S) to be cheaper than High KS Ratooner at the rates in the table above the CK 140(S) would need to be discounted to \$900 per tonne.

The next part of the equation is to grow the best crop possible. Given the longer term weather forecasts range from a dry summer to a wet summer it would be best to plan for the worst and hope for the best.

Water is the key driver of productivity and yield and the best result occurs when the right amount is applied at the right time.

Unless growers have more than 6ML/ha, growers should try and apply as much water as possible given the irrigation application constraints each farm has.

Part of this is because for those on the Sunwater scheme, there's a fixed charge of \$72.23/ML for Part A whether they use the water or not. The 15% rebate has been announced with forms available for eligible growers at reception.

By claiming this rebate eligible growers will be saving approximately \$10/ML.

Fertiliser bag disposal

The Big Bag recovery program which recycles 1T bulk fertiliser bags has moved from Qunaba to the waste facility on University Drive. The site accepts approved (no cost to the grower) and non approved (costs growers \$7/bag) types of fertiliser bags at the Bundaberg Waste Disposal Site on University Road. As the site is not staffed all the time pre booking with at least 24 hours notice should be given.

The approved fertiliser bags include those from Incitec Pivot Limited, Nutrien Ag Solutions, Impact fertilisers, Tarra, GrowForce and Summit Fertilisers. The full list of approved bags can be found at https://www.bigbagrecovery.com.au/#brands.

Non approved brands such as Koch will incur a \$7 per bag disposal fee.

To prepare for disposal an online disposal booking form needs to be completed with a date and time, preferably with 24 hours notice, the bags need to be stacked and folded with the fertiliser brand facing out, and stack the bags onto the vehicle separating the approved and non approved bags. Once at the disposal site a declaration form needs to be completed with up to 300 bags

accepted at one time.

If growers have more than 300 approved scheme bags, they are able to organise for an on-farm collection by Gary Gillis of Beneficial Recycling who can be contacted by email gary.gillis@beneficialrecycling.com.au or phone on 0403 431 705.

Soybean Update

Prices

Soybean prices are similar to or slightly down compared to last year depending on when last year's contract was signed.

The full fat market is depressed as there is a large crop being harvested in the USA and a large plant forecast in Brazil and Argentina who are both planting at the moment. This is putting downwards pressure on the soybean meal and full fat market.

Varieties

There are no changes to the main

varieties suitable for this region and given the likelihood of the crush finishing in mid December, variety A-6785 may not suit the available planting window.

The other main varieties are Hayman^(h) more suited to a January plant date while Kuranda^(h) can be planted into mid February with limited yield penalty. If growing for a green manure crop with an autumn cane plant A-6785 is likely the best option.

Preparation

Soybeans can be direct drilled into



existing cane rows, though generally cultivation occurs to ensure an even paddock for harvesting. The reason for this is that the lowest pods are generally 10cm above ground level.

Lime is often required as soybeans, like most legumes, prefer a pH close to neutral. This also assists nodulation as the Rhizobium bacteria which is applied at planting works best in a neutral soil.
